

Q3 2017 Unlimited Infinity Bundle Offer

Offer Period

1. The offer will be available from 24 October to 27 November 2017 inclusive (“**Offer Period**”) to customers who fulfil the eligibility criteria set out in Paragraphs 4 to 6 below.
2. Except as expressly amended, the standard terms for the BT Business Unlimited Infinity Bundles at www.bt.com/terms will apply, together with Section 59, Part 1, Sub-Part 2 of the BT Price List.
3. The following additional terms will apply to the offer:

Eligibility

4. The offer will be available at BT’s discretion to **new** BT Business customers who, during the Offer Period, sign up to one of the Unlimited Infinity Bundles set out in Paragraph 5 with:
 - a) a **new** BT Business Unlimited Infinity Service; and
 - b) a **new** BT Business Value Line or PSTN Line.
5. The BT Business **Unlimited Infinity Bundles** consist of the following options:
 - a) Unlimited Infinity and Line Bundle;
 - b) Unlimited Infinity and Value Line Bundle.
6. The following customers are not eligible for this offer:
 - a) customers who are re-signing an existing BT Business Broadband, BT Unlimited Infinity or BT Business Infinity Contract;
 - b) customers who are re-grading an existing contract for BT Business Broadband, BT Premium Infinity or BT Business Infinity;
 - c) customers who are transferring from a residential contract to a business contract; and
 - d) customers that have Fibre to the Premise.

7. BT will discount the standard Monthly Bundle Price for the Unlimited Infinity Bundles as set out in Section 59, Part 1, Sub-Part 2 of the BT Price List to the price set out in the table below (excluding VAT) for months 1 to 12 of the Minimum Period of Service:

9. All other Charges, including connection charges for BT Business Unlimited Infinity Bundles will be as set out in Section 59, Part 1, Sub-Part 2 of the BT Price List.
10. The standard Charges for BT Business Unlimited Infinity Bundles, as set out in Section 59, Part 1, Sub-Part 2 of the BT Price List, will apply at the end of the Minimum Period of Service.
